RE: Request that you vote NO on H.R. 23, "The Illegitimate Court Counteraction Act"

Dear Senator Moreno:

The undersigned organizations urgently request you to vote *NO* on Rep..Chip Roy's H.R. 23, the "Illegitimate Court Counteraction Act," which is expected to be voted on by the Senate this week. H.R. 23 is aimed at shielding Bibi Netanyahu and other Israeli leaders from accountability for committing Genocide and War Crimes in Gaza. If you genuinely believe in the rule of law, you should oppose the sanctioning of the International Criminal Court for properly investigating allegations of Genocide and War Crimes by Israeli leaders. At the same time, you must not enable Israel's vast human rights violations by sending weapons to Israel while shielding genocidal perpetrators.

Below is a recitation of documented and overwhelming evidence of Israel's perpetration of genocide and mass murder, crimes against humanity, and crimes of aggression. Israel has committed these offenses with \$26 billion worth of material support from American taxpayers:

A vote to protect Prime Minister Netanyahu and others in his administration could open you up personally to potential criminal and civil liability for aiding and abetting Israel's genocidal war. Under the Rome Statute, public officials, including members of the U.S. Congress, are not immune from prosecution for their official acts in support of genocide, war crimes and crimes against humanity. You could be prosecuted not only at the International Criminal Court, but in virtually any court in any country, including the United States, according to the principle of universal jurisdiction.¹ There is no statute of

limitations for the U.S. federal crimes of committing or conspiring to commit genocide. One who has aided and abetted genocide may not avail herself of Israel's claim of "self-defense."²

Please oppose the insulting and foolish plan to shield Israel's political leaders. Further, please do the following:

• Re-introduce Rep. Cori Bush's Ceasefire Now Resolution³ demanding an immediate cessation of hostilities and a ceasefire throughout the Gaza Strip;

• Support introduction of international peacekeepers into Palestine;

• Support the immediate provision of humanitarian aid wherever needed in Palestine;

• Support immediate and continuous negotiations under United Nations auspices that affirm the right of Palestine to exist and which guarantee its exclusive ownership and control of all natural resources, minerals and fisheries found there.
